In line with para. 6.2 of Art. 6 of [The Dean's Order FSv_PD_2024_06_V01](#) Conditions for Admission to Studies in Bachelor's Degree Study Programmes Implemented at the Faculty of Civil Engineering CTU in Prague in the 2025/2026 Academic Year (hereinafter referred to as "Conditions for Admission to Studies"), pursuant to Art. 18 para. 4 of the Statute of the Faculty of Civil Engineering of the Czech Technical University in Prague, I hereby issue the following Directive:

Article 1
Subject of regulation

I hereby announce an exceptional date of the entrance examination to the following Bachelor's degree study programmes:

- Civil Engineering (instruction in Czech, full-time study)
- Architecture and Building Sciences (instruction in Czech, full-time study)
- Geodesy and Cartography (instruction in Czech, full-time study)
- Construction Engineering (instruction in Czech, full-time study)
- Management and Economics in Civil Engineering (instruction in Czech, full-time study)
- Civil Engineering (instruction in English, full-time study).

Article 2
Deadlines

- (3) The deadlines specified in para. 1 of this article are non-exceedable. No documents can be accepted from an applicant after the expiry of the deadlines specified above without an exception granted individually by the Dean upon the applicant's written request filed ahead of the set deadline.

Article 3

Admission of applicants

- (1) The admission of applicants for study within this exceptional date of the entrance examination is regulated by [Conditions for Admission to Studies](#) and [The Dean's Directive FSv SD_2024_06_V01](#) on Public Announcement of Admissions Proceedings to Bachelor´s Degree Study Programmes Implemented at the Faculty of Civil Engineering CTU in Prague in the 2025/2026 Academic Year (hereinafter referred to as "The Dean's Directive"), except for the deadlines laid down in Art. 2 of this Directive and the numbers of admitted students specified in Art. 3 para. 3 of this Directive.

If more applicants have the same number of points as the applicant in the last place, all these applicants will be admitted.

- (4) Applications are submitted only electronically via the prihlaska.cvut.cz database; they are not printed out or sent to the Faculty on paper.
