Pursuant to § 27, par. 1, letter b) and § 33, par. 3 of Act No. 111/1998 Coll., on Higher Education Institutions and on Amendments and Supplements to Some Other Acts (hereinafter referred to as the "Act"), the Academic Senate of the Faculty of Civil Engineering, Czech Technical University in Prague has decreed the following Statute of the Faculty of Civil Engineering, Czech Technical University in Prague:

The Statute

of the Faculty of Civil Engineering Czech Technical University in Prague

The Statute of the Faculty of Civil Engineering of the Czech Technical University in Prague (hereinafter referred to as the "Statute") hereby regulates its activity, management and organization within the Czech Technical University in Prague (hereinafter referred to as "CTU").

Part One INTRODUCTORY PROVISIONS

Article 1 Fundamental provisions

- 1. The Faculty of Civil Engineering (hereinafter referred to as "FCE") is a constituent part of CTU. It was initially founded as the Estates Engineering School in Prague based on a rescript by Emperor Joseph I of 1707. It follows up the traditions of the University of Civil Engineering and the University of Architecture and Structural Engineering, which became part of the Czech Technical University in 1920. The Faculty of Civil Engineering was established by the Government Decree No. 120/1960 Coll. of the 5th August 1960 by merging the Faculty of Civil Engineering, which had incorporated the Faculty of Surveying in 1959, with the Faculty of Architecture and Structural Engineering.
- 2. The FCE official name is: "Czech Technical University in Prague, Faculty of Civil Engineering".
- 3. FCE is based in Prague.
- 4. FCE address is: České vysoké učení technické v Praze

Article 2 Academic community, academic rights and freedoms

- 1. The FCE academic community defined in § 25, par. 3 of the Act performs FCE self-government, both directly and by means of FCE autonomous bodies in accordance with the Act, the CTU Statute, CTU Internal Regulations and FCE Internal Regulations.
- 2. The academic freedoms and academic rights are regulated in § 4 of the Act.
- 3. It is inadmissible to establish and organize the activity of political parties and political movements at FCE (§ 2 par. 10 of the Act). Trade unions, interest and professional civic groups (associations) of FCE staff, students and graduates may be established and act at FCE.

Article 3 FCE status

- 1. The FCE status is regulated by the Act, the CTU Statute and this Statute.
- 2. FCE is involved in educational activity. FCE is also involved in scientific and research, development and innovation, artistic or other creative activities (hereinafter referred to as "creative activity").
- 3. Following the fulfilment of its fundamental mission pursuant to paragraph 2, FCE is also involved in supplementary economic activity.
- 4. FCE is not a legal entity. In matters regulated in § 24 par. 1 of the Act and in Art. 29 par. 4 to 6 of the CTU Statute, FCE bodies are entitled to make decisions or act on behalf of CTU.

Part Two AREAS OF FCE AUTONOMOUS ACTIVITY

Article 4 FCE mission, Strategic Plan

- 1. In accordance with the principles of democracy and humanism, AS FCE a constituent part of CTU freely:
 - a) provides high-quality university education and lays down its content and forms,
 - b) is engaged in creative activity in agreement with society needs, global trends and principles of the freedom of science, research and creative activity and publication of their achievements,
 - c) participates in the application of the achievements of creative activity in practice,
 - d) establishes autonomous academic bodies to protect and apply these principles and freedoms,
 - e) acts in Habilitation Proceedings and Proceedings for the Appointment of Professors,
 - f) promotes information on the state of the art in the disciplines cultivated at FCE to the professional public,
 - g) supports sports, cultural and other non-political social activities of FCE students, employees and graduates.
- 2. The educational and creative activity at FCE, which follows up its long-term tradition and reflects current development trends, covers mainly the following areas pursuant to Annex No. 3 to the Act: Architecture and Town Planning, Civil Engineering.
- 3. The Strategic Plan of the FCE educational and creative activity and the annual plan of the Strategic Plan implementation (hereinafter referred to as the "FCE Strategic Plan") constitutes the FCE fundamental programme document. The FCE Strategic Plan
 - a) is prepared in accordance with the CTU Strategic Plan,
 - b) is primarily based on the university development concept and the FCE development concept,
 - c) is mainly used in proposals for potential organizational changes, the preparation of new study programmes and research projects.
- 4. After discussion in the SC Scientific Council (hereinafter referred to as "SC FCE"), the FCE Strategic Plan is approved by the FCE Academic Senate (hereinafter referred to as "AS FCE").

Article 5 Study and educational activity

- 1. Study as the student's basic right and duty and educational and creative activity as the academic staff's basic right and duty are conducted within academic freedoms and based on creative activity.
- 2. Study at FCE is organized through study programmes and life-long learning programmes (§ 2 of the Act). The list of programmes is published in the public part of the FCE website.

Article 6 Admission to study

To be admitted to study in a selected study programme the applicant must comply with general conditions pursuant to § 48 of the Act and Art. 6 of the CTU Statute. Additional conditions for admission to study at FCE are announced by the Dean after their previous approval by AS FCE.

Article 7 Bachelor, Master and Ph.D. studies

- 1. Studies in Bachelor, Master and Ph.D. study programmes are organized in accordance with the Study and Examination Rules for Students of CTU in Prague, which is a CTU internal regulation. Additional details related to Ph.D. study are specified in the Code of Practice for Doctoral Degree Study at FCE, which is a FCE internal regulation.
- 2. Bachelor and Master degree study programmes are completed by the final graduation examination (§ 45, 46, 47b and 53 of the Act) including the defence of the final graduation thesis. Ph.D. degree study programmes are completed by the Ph.D. final graduation examination and the defence of the dissertation (§ 47, 47b and 53 of the Act). The conditions for final graduation examinations are laid down in the Study and Examination Rules for Students of CTU in Prague.

Article 8 Life-long learning

As part of its educational activity, FCE offers life-long learning programmes. More detailed conditions for admission to study, the course and completion of life-long learning programmes and related fees are regulated by Art. 8 of the CTU Statute and the Code Governing Life-Long Learning at CTU.

Article 9 Study conditions for foreigners

The conditions for the study of foreigners are regulated by Art. 9 of the CTU Statute.

Article 10 Academic degrees and certificates of completion of study

- 1. Pursuant to § 45 of the Act, the graduates of Bachelor degree study programmes are awarded the degree of "Bachelor" (abbreviated as "Bc.", used before the name), pursuant to § 46 of the Act, the graduates of the Master degree study programme of Architecture and Building Sciences are awarded the degree of "Engineer Architect" (abbreviated as "Ing. arch.", used before the name) and the graduates of the other Master degree study programmes are awarded the degree of "Engineer" (abbreviated as "Ing.", used before the name). Pursuant to § 47 of the Act, the graduates of Ph.D. degree study programmes are awarded the degree of "Doctor" (abbreviated as "Ph.D.", used after the name).
- 2. Pursuant to § 57 of the Act, CTU awards diplomas and diploma supplements as certificates of completion of a study programme.
- 3. According to § 60 of the Act, CTU awards participants of life-long learning programmes certificates of their completion.

Article 11 Study related fees

- 1. Study related fees are collected by FCE based on the rules laid down in § 58 of the Act, Art. 11 of the CTU Statute and Annex No. 5 to the CTU Statute.
- 2. The fees for exceptional and non-standard administrative services are collected by FCE based on the rules laid down in Art. 12 of the CTU Statute and Annex No. 5 to the CTU Statute.

Article 12 Scholarships

FCE students are granted scholarships in accordance with the rules laid down in the Scholarship Regulations of CTU in Prague.

Article 13 Creative activity

- 1. Creative activity is the fundamental right and duty of the FCE academic staff. It is carried out within the scope of academic freedom of scientific research and creative technical or artistic activity being also the basis for educational activity. FCE is open to cooperation with research and artistic establishments and industrial companies both in the Czech Republic and abroad.
- 2. Creative activity at FCE is carried out in the areas specified in this Statute in accordance with the FCE Strategic Plan. FCE strives to create favourable conditions for the creative activity of its academic staff and students.
- 3. On behalf of CTU, FCE enters into legal relations with other entities in cooperation in creative activity and in the interest of the implementation and commercial use of the achievements of this activity.

Article 14 Foreign relations

- 1. FCE organises and develops foreign relations and activities. Foreign relations may also be organised at FCE by civic groups (associations) of employees, students and graduates, or individually by employees and students.
- 2. Foreign relations are primarily organised in the educational, creative and cultural area.
- 3. Contractual relationships with foreign partners must comply with special regulations or international agreements binding the Czech Republic. Agreements may only be signed by individuals who are authorized to act in these matters on behalf of CTU pursuant to Art. 29 par. 5 letter c) of the CTU Statute.

Article 15 Annual reports, evaluation of FCE activity

- 1. The Dean annually submits the annual report on FCE activity and the annual report on FCE economic management to AS FCE for approval.
- 2. Following the approval by AS FCE, the Dean submits the annual reports to the Rector and publishes them on the FCE website.
- 3. The conclusions of annual reports are used in management activity and for the purposes of potential further specifications of the FCE Strategic Plan.
- 4. Regular evaluations of educational, creative and related activities (hereinafter referred to as "internal evaluations") are carried out at FCE in accordance with CTU internal regulations and the FCE Strategic Plan.
- 5. Student opinion surveys conducted after each semester of the academic year are part of the evaluation of educational activity.
- 6. In providing high-quality educational and creative activity and in its internal evaluation, FCE follows the CTU Rules of the System to Ensure the Quality of Educational, Creative and Other Related Activities and Internal Assessment of the Quality of Educational, Creative and Other Related Activities at CTU; these rules are a CTU internal regulation.

Part Three FCE bodies

Article 16 Structuring of FCE bodies

- 1. The self-governing academic bodies of FCE comprise:
 - a) FCE Academic Senate,
 - b) Dean,
 - c) FCE Scientific Council,
 - d) FCE Disciplinary Commission.
- 2. Another FCE body is the FCE Treasurer.

Article 17 FCE Academic Senate

- 1. AS FCE is a self-governing representative body of FCE.
- 2. The status of AS FCE is regulated in § 26 and 27 of the Act.
- 3. The members of AS FCE are elected by the members of the FCE academic community from among its ranks (§ 26 par. 1 of the Act).
- 4. Membership in AS FCE is incompatible with the position of the Rector, Vice-Rector, Registrar, Dean, Vice-Dean, FCE Treasurer and Director of Institute of Higher Education (§ 26 par. 2 of the Act).
- 5. AS FCE and its members report to the members of the FCE academic community. The members of AS FCE protect the interests of FCE as a whole and are guided by their conscience in their decision-making. In the exercise of their office, the members of AS FCE are not bound by the opinion of other FCE self-governing academic bodies or FCE senior managers.
- 6. The members of AS FCE are elected by the academic community by a direct and secret vote. The number of AS FCE members and the manner of their election are regulated in the AS FCE Electoral Code, which is a FCE internal regulation, pursuant to § 26 of the Act.
- 7. AS FCE makes decisions on matters pursuant to § 27 par. 1 of the Act, expressing its opinion mainly on matters pursuant to § 27 par. 2 of the Act. The AS FCE rules of procedure and conditions for constituting the quorum are regulated by the AS FCE Rules of Procedure, which is a FCE internal regulation.
- 8. AS FCE also delegates representatives of the academic community to the bodies of representation of higher education institutions.
- 9. The AS FCE procedure of nominating a candidate for the Dean's position and discussing a potential proposal for their recall is regulated by the AS FCE Rules of Procedure.
- 10. The AS FCE's term of office shall not exceed three years, the members of AS FCE are elected until the end of its term of office.

Article 18 Dean

- The Dean is the supreme representative of FCE and its representative in relations with other faculties of higher education institutions in the Czech Republic and abroad, public institutions and state bodies, particularly the Ministry of Education, Youth and Sports, the commercial sector and citizens.
- 2. The Dean's status is regulated in § 28 of the Act.
- 3. As a FCE representative, the Dean is authorized to make decisions or act on behalf of CTU in matters specified in § 24 of the Act and Art. 29, 34 and 36 of the CTU Statute.
- 4. In areas regulated by the Act, the CTU Statute and this Statute, the Dean issues FCE internal regulations after their approval by AS FCE and the CTU Academic Senate (hereinafter referred to as "AS CTU"). In the scope of their individual competencies, the Dean further releases orders, regulations, measures, directives, decrees or makes other decisions for which they are authorized by the Act, CTU internal regulations and FCE internal regulations.

Article 19 FCE Vice-Deans

- 1. Vice-Deans represent the Dean in the scope of responsibilities specified by the Dean. The Dean authorizes one of the Vice-Deans to represent them to the full extent of responsibilities in the time of their absence.
- 2. Vice-Deans are appointed and recalled by the Dean pursuant to § 27 par. 2 letter b) and § 28 par. 5 of the Act.
- 3. The areas of Vice-Deans' activities are set out by the Dean.
- 4. The competencies of Vice-Deans within the allocated fields of their activity, including the specification of FCE organisational units managed by them, are set out by the Dean.
- 5. In their limited field of activity, Vice-Deans are authorized to act in matters related to FCE within the scope of responsibilities granted to them by the Dean. Within their competencies, they may assign tasks to Heads of Departments. Vice-Deans report to the Dean in their activity.
- 6. Based on proposals from individual Vice-Deans, the Dean appoints and recalls Deputy Vice-Deans and sets out the scope of their powers.

Article 20 FCE Scientific Council

- The chair of SC FCE is the Dean. Other members of SC FCE are appointed and recalled by the Dean after their approval by AS FCE pursuant to the principles laid down in § 29 of the Act. Membership in SC FCE is irreplaceable. When appointing SC FCE members, the Dean ensures that all the main fields of the educational and creative activity practised at FCE are represented in it. SC FCE has a maximum of 40 members.
- 2. The SC FCE competencies cover discussions about and the approval of issues and areas specified in § 30 of the Act. SC FCE also expresses its opinion on matters submitted to it by the Dean.
- 3. The SC FCE's term of office is four years and its end usually coincides with the end of the Dean's term of office.
- 4. A SC FCE member may resign from the membership in SC FCE before the expiry of its term of office by written notice submitted to the Dean. The Dean appoints a new member in their position, or in the position of a recalled SC FCE member, following their approval by AS FCE and observing the principles specified in § 29 of the Act.
- 5. The convention of SC FCE, its decision-making method and other procedural issues related to its acts are regulated by the SC FCE Rules of Procedure, which are a FCE internal regulation.
- 6. In justified cases, the Dean may also appoint extraordinary SC FCE members. Extraordinary SC FCE members receive all written materials like regular SC FCE members and are entitled to participate in all SC FCE sessions (including non-public parts of SC FCE sessions) with an advisory vote.

Article 21 FCE Disciplinary Commission

- 1. The members of the FCE Disciplinary Commission are appointed and recalled by the Dean observing the principles specified in § 27 par. 1 letter f) and § 31 of the Act. This commission resolves disciplinary offences of CTU students enrolled in the study programmes organised at FCE.
- 2. Disciplinary proceedings are regulated in § 64 to 69 of the Act.
- 3. The proceedings and hearings before the FCE Disciplinary Commission are conducted in accordance with the Disciplinary Code for Students of CTU.

Article 22 FCE Treasurer

- 1. The Treasurer's status is regulated in § 32 of the Act.
- 2. The Treasurer is appointed and recalled by the Dean.
- 3. The Treasurer is in charge of the economic management and internal administration of FCE within the scope of responsibilities stipulated in the Dean's Measure.
- 4. The Treasurer is responsible for the management of FCE resources in accordance with special regulations, CTU and FCE internal and other regulations and in accordance with the rules for the planning and management of the FCE budget.
- 5. The Treasurer manages the activity of the Dean's Office in all areas except for the cases where the

FCE Organisational Rules stipulate otherwise.

Part Four FCE WORKPLACES

Article 23 FCE organizational structure

- 1. FCE is divided into departments and other research, administration, service, special-purpose and other units which are listed in the FCE Organizational Rules (Annex No. 1).
- 2. The functional positions of Heads of FCE departments are filled in accordance with the Rules of Selection Procedure to Appoint Academic Workers at CTU, which is a CTU internal regulation.

Article 24 FCE Dean's Office

The Dean's Office is in charge of the economic, operations and administrative management of FCE and creates material and operating conditions for its activity. The organization and management of the Dean's Office are regulated by the FCE Organisational Rules (Annex No. 1).

Article 25 FCE academic advisory boards

- 1. FCE academic advisory boards are established by the Dean. They may be permanent or set up on an ad hoc basis.
- 2. The Dean's permanent advisory boards are the Dean's Collegium and the Dean's Gremium. The Dean's Collegium members are: the Dean, Vice-Deans, Treasurer, AS FCE Chair and other employees appointed by the Dean. The Dean's Gremium is composed of the Dean's Collegium members, the Heads of Departments and research units and other employees or students appointed by the Dean.
- 3. The Dean's Collegium and the Dean's Gremium are summoned and their proceedings are managed by the Dean. The details related to the Dean's Collegium and the Dean's Gremium activity are laid down by the Dean.

Part Five FCE STUDENTS AND EMPLOYEES

Article 26 FCE students

- 1. The status, rights and obligations of FCE students are regulated by the provisions of § 61 to 63 of the Act, CTU internal regulations and FCE internal regulations.
- 2. The details of the course of study at FCE and administration in matters related to study are regulated by the Study and Examination Rules for Students of CTU in Prague, the Code of Practice for Doctoral Degree Study at FCE, the Dean's Directives and documentation of study programmes.
- 3. The academic degrees awarded to graduates of individual study programmes and the issue of certificates on completion of study are regulated in the Act (§ 45 to 47 and § 57) and Article 10 of this Statute.
- 4. A deliberate infringement of obligations stipulated by legal regulations, CTU internal regulations and FCE internal regulations may be considered as a disciplinary offence pursuant to § 64 of the Act and may be penalized by some of the sanctions under § 65 of the Act. The details are specified in the Disciplinary Code for students of CTU.

Article 27 FCE employees

- 1. The employees working at FCE including the employees whose work at FCE is based on contracts for work or agreements on work performed outside an employment contract are in labour relations with CTU.
- 2. The Dean is authorized to make decisions and act on behalf of CTU in labour relations pursuant to § 24 of the Act and Art. 34 of the CTU Statute.
- 3. The FCE academic staff are employees in labour relations with CTU listed in § 70 of the Act engaged in both educational and creative activity at FCE depending on the agreed type of work.
- 4. Together with the academic staff, other experts may participate in teaching based on agreements on work performed outside an employment contract (§ 70 par. 3 of the Act) and Visiting Professors or Professors Emeritus (§ 70 par. 4 of the Act).
- 5. The positions of the academic staff at FCE are filled pursuant to provisions of § 77 of the Act. Details are stipulated in the Rules of Selection Procedure to Appoint Academic Workers at CTU, which is a CTU internal regulation. Other positions at FCE filled by a selection procedure are specified by the Dean.
- 6. Pursuant to the principles specified in § 76 of the Act, a FCE academic staff may be granted a sabbatical leave. The granting of the sabbatical leave is decided by the Dean.
- 7. Habilitation Proceedings and Proceedings for the Appointment of Professors are regulated by the provisions of § 71 to 75 of the Act. The procedure of Habilitation Proceedings and Proceedings for the Appointment of Professors is further specified by the Rules of Habilitation Proceedings and Proceedings to Appoint Professors of CTU, which is a CTU internal regulation.
- 8. Based on the Dean's proposal, the Rector may appoint a professor who has terminated the contract for work with CTU Professor Emeritus. The appointment, activity and status of the Professor Emeritus are regulated by the Statute of Emeritus Professors of CTU, which is a CTU internal regulation.
- 9. Based on the Dean's proposal, the Rector may appoint a Visiting Professor. The appointment, activity and status of the Visiting Professor are regulated by the Statute of Visiting Professors of CTU, which is a CTU internal regulation.

Part Six FCE FUNDING AND ECONOMIC MANAGEMENT

Article 28 FCE funding

- 1. FCE funds its activities from subsidies and a contribution from the state budget allocated by CTU, resources gained from supplementary economic activities, donations and other sources.
- 2. The Dean is authorized to manage the property registered at FCE on behalf of CTU with the exception of legal acts specified in § 15 par. 1 of the Act and Art. 36 par. 5 of the CTU Statute.
- 3. FCE is entitled to use business licenses or licenses for business activities under special regulations which are a precondition for the performance of economic activity under § 20 par. 2 of the Act, whose holder is CTU.

Article 29 FCE economic management

- 1. FCE management is regulated by the principles stated in § 20 of the Act, Art. 37 of the CTU Statute and CTU Rules of Economic Management, which are an annex to the CTU Statute.
- 2. FCE keeps accounts as a CTU accountancy office.

Article 30 Economic audit

- 1. Pursuant to Art. 38 of the CTU Statute, economic audits are conducted by professionals among employees applying superior-subordinate relationships:
 - a) periodically,
 - b) exceptionally based on the Dean's or the Rector's decision.
- 2. All FCE workplaces must submit all necessary documentation for an economic audit without delay. On request, they are obliged to submit a written statement on the audit findings.
- 3. AS FCE carries out audits of the use of FCE financial resources.

Part Seven FCE ACADEMIC CEREMONIES

Article 31 Insignia and academic robes

- 1. FCE insignia are an external representation of the authority and responsibility of FCE representatives at academic ceremonies and on other ceremonial occasions.
- 2. FCE insignia include the Dean's sceptre, the Dean's and Vice-Dean's chains.
- 3. The Dean's sceptre is used at CTU and FCE academic ceremonies.
- 4. The Dean and Vice-Deans are entitled to use the chains, which are FCE insignia, at academic ceremonies and on other ceremonial occasions. The other FCE chains may be used by the AS FCE Chair, promotors and other academic staff according to the Dean's instructions. Academic robes may be used at academic ceremonies and on other ceremonial occasions by the Dean, Vice-Deans, the Treasurer, AS FCE Chair, SC FCE members, academic staff and other persons according to the Dean's instructions.

Article 32 Dean's inauguration

- 1. The Dean's inauguration after his/her appointment by the Rector is held at a ceremonial gathering of the FCE academic community or at a public session of AS FCE.
- 2. During the inauguration, the Dean takes an oath whose wording is stated in Annex No. 3 to the CTU Statute, before the AS FCE Chair.
- 3. After the ceremonial oath, the AS FCE Chair hands the Dean's chain to the Dean as a symbol of the Dean's authority and responsibility.

Article 33 Matriculation and graduation ceremonies

FCE organizes matriculation ceremonies for students and graduation ceremonies for graduates in Bachelor and Master degree study programmes. The graduation ceremonies for graduates in Ph.D. study programmes and the presentation of appointment decrees to associate professors are organized by the CTU Rector's Office. Part of these ceremonies is the matriculation academic oath, the Bachelor's, Master's, doctoral and associate professor's graduation oath whose wordings are listed in Annex No. 3 to the CTU Statute.

Article 34 Medals awarded by FCE

- 1. FCE awards its employees and other individuals Šolín's Medals, Rektorys' Medals and Bažant's Medals for outstanding merits in the development of FCE or a contribution to the development of education and science.
- The criteria for awarding the medals are stipulated in Medal Statutes approved by AS FCE. Šolín's Medals are awarded by the Dean following an approval by AS FCE. Rektorys' or Bažant's Medals are awarded by the Dean following an approval by SC FCE.
- 3. The documentation of the medals awarded by FCE and their accompanying diplomas are filed in the FCE Archive.

Part Eight COMMON, TEMPORARY AND FINAL PROVISIONS

Article 35 FCE seals

- 1. FCE uses a circular stamp with a small state coat of arms and the text in Czech reading "Czech Technical University in Prague Faculty of Civil Engineering".
- 2. In public legal acts on behalf of CTU, the Dean uses a circular stamp with a small state coat of arms, the text in Czech reading "Czech Technical University in Prague" and the code F1.
- 3. The use of circular stamps is regulated by the Registrar's Directive.
- 4. FCE and its workplaces also use line stamps with the text in Czech reading: "Czech Technical University in Prague, Faculty of Civil Engineering" and the added name of the respective workplace. All stamps are fitted with a serial number under which they are officially filed.

Article 36 Official board and postal delivery

- 1. FCE has established its official notice board for the publication of all data pursuant to the Act, CTU internal regulations and FCE internal regulations.
- 2. The official board must be clearly marked and placed in a permanently publicly accessible place at the address where FCE is based. The content of the official board is also published in a manner that allows remote access (in the public part of the FCE website).
- 3. Decisions to students and applicants for study are delivered by post pursuant to Art. 45 par. 3 to 6 of the CTU Statute.

- 1. The FCE Statute of the 6th June 2007 as amended and supplemented is hereby repealed.
